4. Texas Roadhouse (Liquor License Violation) – July 9, 2013

"On July 9, 2013 at 1900 hours, Sergeant Palumbo and Detective Turcotte responded to the Texas Roadhouse (1200 Quaker Lane) with underage alcohol surveyor, Calvin Carpenter (DOB 12/21/1992). Carpenter was identified as being 20 years of age, based on the Rhode Island identification provided for the purpose of this survey.

The alcohol surveyor entered the establishment of Texas Roadhouse, located at 1200 Quaker Lane. Upon approaching the bar, he had been instructed to purchase one 12-ounce bottle of Heineken beer with currency provided by officers. The alcohol surveyor notified officers shortly thereafter that he had successfully purchased alcohol (the beer) at the bar and identified the bartender.

Officers entered the establishment and spoke with the bartender, identified as Rachel Grillo (DOB 10/2/84). Grillo was advised at the time that she had served an underage male subject at the bar. At which time she confirmed that she did not ask him for identification nor ask him his age prior to serving him. She was advised of the RI General Law, and all personal information was obtained. She was advised that this was currently a survey and that no criminal actions would be forthcoming."

Due to the aforementioned facts the management of Texas Roadhouse is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.

16. STATE LAW AND REGULATIONS: These regulations are in addition to State Law regulations to which all licenses are subject.

RIGL 3-8-5: Penalty for violations relating to underage persons. – Any person who sells of suffers to be sold or delivered any beverage to a person who has not reached his or her twenty-first (21st) birthday either for his or her own use or the use of his or her parents or any other person, or allows any person who has not reached his or her twenty-first (21st) birthday to drink beverages on premises licensed under this title of suffers or allows any persons who have not reached their eighteenth (18th) birthday to sell or serve any beverage on the premises shall for the first offense be subject to a fine of two hundred fifty dollars (\$250); for the second offense, be subject to a fine of five hundred dollars (\$500), and for the third and any subsequent offense, be subject to a fine of seven hundred fifty dollars (\$750). In the event that there are no offenses in three (3) successive years from the date of the last offense, then the next offense shall be treated as a first offense. Nothing in this chapter shall be construed to prevent licensees from hiring any person who has reached his or her eighteenth birthday.

5. Yokohama Japanese Restaurant (Liquor License Violation) – July 9, 2013

"On July 9, 2013 at 1841 hours, Sergeant Palumbo and Detective Shaun Turcotte were completing the alcohol purchase survey. The officers were currently with an underage alcohol surveyor,

Calvin Carpenter (DOB 12/21/92). Carpenter was identified as being 20 years of age, based on the Rhode Island identification provided for the purpose of this survey. At which time the officers responded to Yokohama Japanese Restaurant located at 300 Quaker Lane. The alcohol surveyor entered the restaurant with currency provided by the officers to purchase one 12-ounce bottle of

Heineken beer. Shortly thereafter, the alcohol surveyor reported to the officers that he had been served.

Upon entering the establishment, the officers spoke with Alexander Roskowski (DOB 7/27/85), who was the bartender at the time. He confirmed that he did serve the alcohol surveyor without asking for his age or identification. Personal information was obtained from Roskowski, and Roskowski was warned of his actions. There are no criminal charges forthcoming."

Due to the aforementioned facts the management of Yokohama Japanese Restaurant is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.

STATE LAW AND REGULATIONS: These regulations are in addition to State Law regulations to which all licenses are subject.

ACTION:

6. Wasabi Japanese Restaurant (Liquor License Violation) – July 19, 2013

"On July 9, 2013, Detective Turcotte, along with Sergeant Palumbo and an underage alcohol surveyor, identified as Calvin Carpenter (DOB 12/21/1992), who was identified as being 20 years of age, based on the Rhode Island identification provided for the purpose of this survey, conducted an alcohol survey at the Wasabi Japanese Restaurant located at 1276 Bald Hill Road.

The alcohol surveyor entered the premises with currency provided to him by the officers. Upon approaching the bar, the alcohol surveyor requested a single 12 oz. bottle of Heineken beer. At which time he was subsequently served. The served, later identified as David Chen

(DOB 11/14/76), at no time asked the alcohol surveyor for his age, nor did he request photographic identification prior to providing the surveyor with alcohol.

David Chen was interviewed by Detective Turcotte and Sergeant Palumbo; at which time the pertinent information was obtained, and Chen was advised of the status of the alcohol survey. At this time there are no criminal charges forthcoming."

Due to the aforementioned facts, the management of Wasabi Japanese Restaurant is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.
